MINUTES OF RICHMOND AND BARNES DEANERY SYNOD

Monday October 16th 2017 - 7.30 pm

at ST. MARY, BARNES Church Rd, Barnes, London SW13 9HL

The meeting took place in the shock of the death six days previously of the Rev Trevor Patterson, Vicar of Holy Trinity and Christ Church Richmond and Area Dean of Richmond and Barnes.

On the morning of his death Trevor had written this prayer:

Lord, thank you that you live within me. May your amazing grace flow out of everything I do. Fill me today with the knowledge of your extravagant love and the intimate friendship of the Holy Spirit.

- Marian Mollett introduced Andrew Brown, Secretary to the Church Commissioners. Andrew described the role of the Church Commissioners in the mission of the Church and answered many questions. The talk is outlined in the slides attached.
- 4 Minutes of meeting of 10 May 2017 were accepted.
- Synod unanimously adopted new rules set out in "The Role of Deaneries and the Rules and Constitution of Deanery Synods" which had been approved by the Southwark Diocesan Synod in July 2017. The meeting formally
 - a. adopted the new Rules as set out in Part B VI and Appendix A of the document
 - b. received and noted the remainder of the document.
- Election of Lay Chair and Treasurer. No other nominations having been received, Marian Mollett was elected Lay Chair and Veronica Willoughby was elected Treasurer for the period until the meeting of Deanery Synod immediately following the next election of Lay members of Synod in 2020. The post of Secretary remains unfilled.
- 7 Parish Support Fund pledges for 2018. Marian Mollett commented that all parishes had made pledges. There is an overall increase of

just over 1% from the Deanery, to £1.26m, slightly less than the diocese had hoped for.

- Run the national clergy payroll

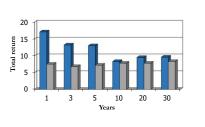

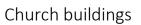
Supporting the Church's ministry

- Additional distributions: To support the Renewal and Reform agenda. Agreed following consultation with dioceses, Synod, House of Bishops and Archbishops' Council. And additional money for building new Lambeth Palace Library.
- **2017-19 spending plans**: In partnership with Council and Archbishops' Spending Plans Task Group. Balance of funding between main categories broadly maintained.



Pastoral reorganisation

- Reorganisation in response to demographic change in population and changing shape of ministry
- Commissioners hear objections to schemes
- Committee considered 10 cases in 2016
- Helps Church adapt to serve communities' pastoral/ mission needs
- Gives objectors independent resolution to disagreement (away from the locality)





- Mission element to the Church's handling of its closed churches
- Open and fair procedures, and professional support to dioceses
- 16 schemes in 2016: 12 alternative uses; 3 for preservation by CCT; 1 demolition
- Committee heard objections to 4 cases. Decided they should all proceed.
- Sales proceeds to help fund living Church (£1.45m in 2016)
